

## PRIVACY NOTICE

At Wallington Cars and Couriers Ltd we are committed to protecting your privacy. This policy applies when we are acting as a controller of personal data, i.e. where we have determined the purposes and means of the processing of that personal data. It applies to employees of organisations with which we are seeking to establish a business relationship.

We will process your personal data for the purpose of communication with your employer. The legal basis for this processing is that it is necessary to achieve our legitimate interest, namely providing information on our services that may be of value and establishing a business relationship with your employer.

We will retain all personal data we have obtained relating to you for a maximum of 5 years to fulfil the purposes for which we collected it, including for the purposes of satisfying any legal, accounting or reporting requirements.

We will share your personal data with our suppliers only to the extent that the disclosure is reasonably necessary for the purposes of seeking to establish a business relationship with your employer and enhancing the relevance of any any communications we have with you and/or your employer.

As you are providing us with your personal data, it is important to us that you are aware of the following rights that you have in relation to our processing of that personal data.

- You can be provided with a copy of any personal data concerning you that we process, unless that would affect the rights and freedoms of others. You can also be provided with information on how that personal data is processed by us.
- You can have us rectify any personal data of yours that we hold that is inaccurate or incomplete. In certain circumstances, you can also ask us to erase or restrict the use of any of your personal data that we process.
- You can object at any time to our processing of your personal data on grounds related to your particular situation.
- You can object at any time to our processing of your personal data for direct marketing purposes.

You can exercise any of the rights listed above by contacting us using the details at the bottom of this notice. If you are unhappy with any aspect of how we processed your personal data or your request to exercise a right, you can lodge a complaint with the Information Commissioner's Office.

We use Google Analytics and Lux Real User Monitoring (RUM) software to collect information about how you use [www.wallingtoncars.com](http://www.wallingtoncars.com) and how the website performs during your visit. This includes IP addresses. The data is anonymised before being used for analytics and web performance monitoring.

Google Analytics processes anonymised information about:

- The pages you visit on [www.wallingtoncars.com](http://www.wallingtoncars.com)
- How long you spend on each wallingtoncars.com page
- How you got to the site
- What you click on while you're visiting the site

Lux Real User Monitoring software processes anonymised information about:

- How well the pages performed on your device
- Performance bottlenecks your device experienced
- Javascript errors your device encountered

We do not store your personal information through Google Analytics or Lux (for example your name or address)

We will not identify you through analytics information, and we will not combine analytics information with other data sets in a way that would identify who you are.
